LD 1163: An Act to Amend the Garnishment Laws of the State (If pass this would allow landlords who pursue and win a small claims to garnish tax returns)
Work session was scheduled on January 21, 2016.

Business: Motion was made by Charlie, and seconded by Royce, to accept the November 10, 2015 Board minutes. Motion passed unanimously.

Motion was made by Charlie, and seconded by Cheryl, to accept the Treasurer's report from January 1 through December 7, 2015. Motion passed unanimously.

Audit of CAHA Books: It was the consensus of the Board of Directors to have Emmy Swanson audit CAHA's financial books in January.

J&S's Monthly Admin Fee: The Board of Directors discussed at length the matter of J&S owing CAHA the admin fees from April 1, 2014 to May 31, 2015. The Board of Directors also discussed the admin fee for CAHA's 2015-2016 contract with them.

It was the consensus of the Board of Directors to have John contact J&S's District Manager to explore the \$0.02/gal reimbursement collection from April 1, 2014 to May 31, 2015, as well as the admin fee for CAHA's 2015-2016 contract with J&S.

Fielding's Yearly Admin Fee: After a short discussion, it was the consensus of the Board of Directors to have Ratna contact Fielding's to collect last year's admin fee.

Updating Heating Oil Prices on CAHA Website: Ratna informed the Board of Directors that Lisa Montagna had given her notice of resignation to take effect on December 2015 or January 2016. Lisa will no longer post the daily oil prices on the website, nor will she assemble the newsletter.

Ratna proposed to the Board of Directors that he will update daily oil prices on the website for the same monthly fee as Lisa of \$70. The consensus was to accept Ratna's proposal, but John wants to discuss the matter with Lisa.

2016 Annual Banquet: Ramona informed the Board that the Elks Club had confirmed the date of the Annual Banquet for Tuesday, February 9, 2016.

Board Members Term to End 2016: The three Board of Directors, whose terms will be ending in 2016, are Ratna Don, Barbara Eckhardt, and Royce Watson. Ratna Don has stated he will not run for another term.

CAHA Annual Filing with the State of Maine: A lengthy discussion ensued on this agenda item.

It was the consensus of the Board of Directors to have Sue set up a meeting with CAHA's Clerk, Eric Dick, to discuss a reasonable flat rate for his annual CAHA filing with the State of Maine. Sue will give a report of this meeting at the January Board meeting.

December Newsletter: Barbara volunteered to write a Secretary's message to the members in the December Newsletter.

Since this would be the last newsletter Lisa Montagna will be doing for CAHA, John requested that Sue ask her daughter Bridget to consider taking over assembling the newsletter, mailing it to the printer, emailing the newsletter using Constant Contact to the members, and posting it to website for a flat fee of \$50 a month.

Ramona volunteered to contact Copy Etc to see if they may be willing to do the aforementioned newsletter assembly job.

City of Augusta's Property Maintenance Code:

It was the consensus of the Board of Directors to inform CAHA's members that on November 10, 2015, a city council meeting was held for the discussion of its **2015 property maintenance code** and to urge them to become versed in this code by going to the city website for further detailed information.
