A letter from Director of Communications, Government and Media Counsel, Maine Judicial Branch about FED (forcible entry and detainer) process

On behalf of the Maine Judicial Branch, let me begin by expressing thanks for all of your efforts to "come to the table," bringing constructive suggestions and a willing attitude to the task of providing enhanced opportunity for mediation and settlement in FED cases. We, too, have been making efforts to design a process that could provide additional time, and opportunity for mediation and settlement, between the commencement of the court process and the final hearing. The information sheet and mediation request form is in circulation, and we are adding your updates with the plan to post a revised version for use beginning this month.

As you are probably aware, the changes to the Maine Rules of Civil Procedure necessary to implement the planned new FED process are significant. The necessary change to the FED summons to include two dates (to give notice of the mediation day) is significant. Providing notice on the website and helping litigants to find it is a significant "ask." The degree of change to the rules and the challenges inherent in the plan, albeit known from the start, are sobering. In addition to this, informal comments received by the court from the bar have raised new concerns about challenges that will arise if all courts double the number of FED days on their dockets, even if one is remote. It is likely that all members of the group have had some reservations about the proposed process.

Given these considerations, and given that requests for mediation are already being received by the court, at this time the court is adjusting its expectations, and will postpone implementation of any new process, while tracking the volume of requests for mediation received. The tracked information should be very helpful in assessing next steps. During the evaluation process, requests for mediation will be addressed on a case-by-case basis, and, if necessary, a new mediation process will be developed as and if the need becomes evident.

While I understand that this news might be something of a disappointment, pursuit of such a significant change will be better served if underpinned with data and experience in the case-by-case scenario. As we continue to work on this process, we would be grateful for your continued input and appreciate your willingness to work with us.

The Maine Judicial Branch thanks you again for all of your diligent efforts and work to improve the FED process in Maine.
